de Brimont develops initiatives that support IOM's commitment to the principle that humane and orderly migration benefits migrants and society. Her work has focused on facilitating the resettlement of refugees in France and protecting migrants against trafficking. Her initiatives at IOM Paris include production of an informational video used by IOM staff in countries of departure (Turkey, Lebanon and Jordan) to provide legal and cultural orientation information to Syrian refugees before their resettlement in France. She also served as developer and coordinator of a French national project providing reintegration assistance to trafficking victims returning voluntarily to third countries. This project also provided training to civil servants of the French Office for Immigration and Integration (OFII) on identification and referral of trafficking victims.
